After attending this session, participants will be able to compare and understand all the scaffolding systems and procedures between Frame, Tubular and Modular types.

This Competency Scaffolding training is approved and recognized by DOSH. It is 100% HRDF claimable. Participating company will be given an approved 20 CIDB CCD Points for each employee attended this training as well as 10 DOSH CEP Points.

A briefing on the Work Based Learning programme by Politeknik Sultan Salahuddin Abdul Aziz Shah (Politeknik Shah Alam) was held for their Bachelor of Technology in Facilities Management students on 7th August 2017 at Administration Building, Politeknik Sultan Salahuddin Abdul Aziz Shah. The Polytechnic have 17 Bachelor degree students who will undergo the WBL programme starting on 11th September 2017 for the duration of 20 weeks in semester 7 plus 20 weeks more in semester 8. MBAM Council have approved to collaborate with the Polytechnic to provide placements for them.

Requirements by Politeknik Shah Alam for interested companies are as follows:

- Able to offer the full range of facility management services in order to provide exposure to their students (students can be deployed to multiple sites during attachment)
- Min 2 students to be attached per company
- Participating companies to nominate One (1) Facilitator and Two to Four (2-4) Mentors to coach the students for the subjects of Semester 7 and 8 (see Table below).
- One person can be Mentor for Two (2) subjects max per Semester

Allowances for the students are up to the Participating Companies and is not part of the Certificate of Collaboration.

All students are protected under Politeknik Shah Alam's Group Insurance and have valid CIDB Green Cards. Orientation Workshop for Nominated Mentors will be held by Politeknik Shah Alam in the 1st week of September 2017 to brief them on the Syllabus, requirements by MQA for this Bachelor Degree programme and other related matters. Finally, the students will start their attachment at Participating Companies on 25th September 2017.

He reminded them of the expiry date line of 31st December 2017 and encouraged all to quickly register with MBAM to avoid the last minute rush.

The United Malaysia Contractors Association (UMCA) – Master Builders Association Malaysia (MBAM) Dialogue was held on 12th August 2017 at Sutera Hotel, Seremban in conjunction with the Kin Cho Hong Negeri Sembilan 93rd Anniversary Dinner. MBAM President, Mr Foo Chek Lee, MBAM Executive Director, Ms Loh Mei Ling, MBAM Assistant General Manager, Mr Michael Thong and MBAM Manager, Ms Chai Min Fung attended the dialogue between UMCA and MBAM.

UMCA Secretary General, Mr Sinn Fuh Ming commenced the dialogue in which he outlined the main objectives of the dialogue: to address issues affecting the members and to solicit assistance from MBAM to help to resolve. He urged members to discuss the most important issue which was the E-card and rehiring programme where they faced a lot of obstacles in getting renewal of their foreign workers.

Mr Foo Chek Lee informed that the E –card programme had long expired and he urged them to start to register their foreign workers under the rehiring programme. He cautioned them the problems and shortfalls of engaging Agents for submission of application for the rehiring programme such as high cost, delays, and non-performance of the Agency. He informed them on the collaboration between MBAM and Construction Labour Exchange Centre Berhad (CLAB) to assist MBAM members in the rehiring programme. He detailed out some of the advantages of the collaboration such as staggered payment scheme, faster processing time, and liability of foreign workers under CLAB.



Due to time constraints, Mr Foo Chek Lee moved on to address other matters which was the Implementation of IBS in the Klang Valley by 2018 for project value of RM50 million and above and with an IBS score of 50 percent. He also briefed on the Employment Insurance Scheme which was supposed to take effect on 1st January 2018. He reminded the enforcement of scaffolding will take effect on 1st January 2018 and cautioned all the attendees from using non approved scaffolding.

The general opinion is China contractors do bring everything from China but they can also work with local companies provided the local company can work according to their schedule and requirements.

On the EIS, Mr Foo Chek Lee updated the attendees on the latest development. On the CLQ, both MBAM and CIDB talked about the latest development especially on the two different standards, one by CIDB on Standards Malaysia (Temporary

Construction Site Workers' Amenities and Accommodation — Code of Practice (MS2593:2015)) and one by Jabatan Tenaga Kerja.

The Rehiring Programme for foreign construction workers was another issue that attracted a lot of feedback from MBAM Affiliate Members. The consensus was the programme cost is still very high and some of the requirements set by the implementing agency makes some employers ineligible to register their illegal foreign construction workers.

The Affiliate Dialogue ended with a Press Conference to highlight the issues raised to the public at large.
