JUNE 2017 BULLETIN

On 30th June 2017, MBAM released a statement to appeal to the Government to extend the E-Card registration until 15th February 2018 to coincide with the closing date of the Rehiring Programme. MBAM would seek the assistance of the Immigration Department of Malaysia to resolve issues pertaining to the problems and delays in registering for the E-Cards. We hope the Government will consider to simplify the registration procedures to encourage more employers to come forth to register their illegal workers.

MBAM would like to propose that the Government do not collect the RM600.00 upfront charges as agreed earlier for the Rehiring Programme during the E-Card registration as it would impact the registration process.

THE 8TH INTERNATIONAL INFRASTRUCTURE INVESTMENT AND CONSTRUCTION FORUM

MBAM Council Member cum Environment and Green Technology Chairman, Mr Lau Yew Mun and MBAM Assistant General Manager, Mr Michael Thong represented MBAM at the 8th International Infrastructure Investment and Construction Forum which was held in Macao on 1st to 2nd June 2017. The opening ceremony was officiated by Chief Executive, Macao Special Administrative Region, Mr Chui Sai On and Chairman of China International Contractors Associations, Mr Fang Quichen. The highlights of the opening event were the signing ceremony of "The China and Portuguese-speaking Countries Co-Operation and Development Fund Headquarter; unveiling and the launching of "The Belt and Road Infrastructure Development Index (2017) (BRIDI) and The Report on the Belt and Road Infrastructure Development Index (2017)." The objectives of the BRIDI were to provide information to Chinese contractors and investors on cross border infrastructure projects, business and cultural environments and risks factors of various country.

The highlight of the day was the "Roundtable for Chairmen of International Associations" forum which saw the participation of Mr Lau Yew Mun representing MBAM, where he presented the paper on "Sustainable Infrastructure Development in Malaysia." He touched on the contribution of the construction industry towards the GDP, the rising environmental concerns such as the climate change and the plentiful business opportunities associated with it. On the macro level he presented the Construction Industry Transformation Plan and highlighted that "Environmental Sustainability" is one of its thrusts and requisites towards transforming Malaysia into a developed country.

In rounding up the forum the secretariat announced the rotation and handing over of the Joint Action Plan Secretariat post to Ghana. Mr John Asford Afful on behalf of his country Ghana, gracefully accepted the post and in his acceptance speech he promised to upkeep the tradition and high standards set by the China International Contractors Association.

45TH BIPC MEETING

MBAM Executive Director, Ms Loh Mei Ling attended the 45th Building Industry Presidents' Council Meeting held on 14th June 2017 at Wisma Real Estate Housing and Developers' Association, Malaysia (REHDA) Conference Room, Kelana Jaya, Petaling Jaya.

Some of the issues discussed were as follows:-

- (i) BIM Adoption – CIDB has allocated some funding and a Working Group has been formed. The funding has not been finalized but the Committee is proposing to have a grant ratio of 50:50 for Professionals who adopt the use of BIM.

- (ii) The Social Impact Assessment (SIA) guideline is ready but not presented to the public yet.
- (iii) Update on IBS – MBAM has been requested to help draft a letter for BIPC to submit to the Government on the proposed incentives and skilled workers required in order to make the IBS work.
- (iv) RISM has requested all to use only the services of registered valuers with the Board of Valuers, Appraisers and Estate Agents Malaysia.
- (v) The final determination of the Safeguard Act 2006 effective 14th April 2017 have seen the Government imposing final duties on rebar, steel wire rods and deformed bar in coils import for three years namely 13.42% for year one, 12.27% for year two and 11.10% for year three.
- (vi) More than 600 applicants applied for the CIDB Interview Sessions for Site Supervisor Accreditation. Passing rate is around 80%.
- (vii) Two meeting were held with Jabatan BOMBA on 19th May 2017 and 6th June 2017. BOMBA have informed that only private lift lobby needs insulated doors but this does not apply for lift which are opened up to protected lobby area.
- (viii) CIDB will be enforcing the Act 520 on the Scaffolding material requirement with effect from 1 January 2017. The steel scaffolding must comply with the material code to MS 1462. Currently CIDB and DOSH will apply soft enforcement. For existing scaffold, they require PETW to certify and confirm the safety of the installation. However, new projects are required to comply with the new scaffold requirements.
- (ix) With the deadline for Enforcement Card (E-card) expiring on 30th June 2017. MBAM has urged its members who had hired illegal foreign workers without work permits to register their workers for the E-card and rehiring process before this deadline to avoid heavy penalty imposed.

The briefing was attended by MBAM Vice President and Chairman of Education Committee, Tan Sri Dato' Sri Sufri bin Haji Mohd Zin, MBAM Mechanical & Electrical Committee Member, Mr Norman Wong, and MBAM Assistant Manager, Mr Mohd Hanif bin Ismail. Present from Politeknik Shah Alam were Puan Zaleha bt Abdullah, Head of Department, Puan Zarinah bt Zaini, Head of Programme, Puan Sumaini bt Che Maid and En Hasmawi bin Khalid.

The WBL programme for Bachelor of Technology in Facilities Management with Honours students will be at the end of a 4-year degree programme (Semester 7 and 8). It commenced in 2013 and is now in its 3rd year, with current industry partners including TMR Urusharta (M) Sdn Bhd. In the briefing, Politeknik Shah Alam mentioned that participating companies will need to take in minimum 2 students, and they are looking for companies that provides the full range of facilities management services in order to provide exposure the students.

Chairman of Education Committee, Tan Sri Dato' Sri Sufri told the representatives from Politeknik Shah Alam that the Committee will table the proposed WBL programme in the next Council Meeting on 21st July 2017.

In addition, he highlighted the founding members of Hua Zong were originally from the construction industry and cited some prominent members such as Tan Sri Dato' Seri (Dr) Yeoh Tiong Lay, Tan Sri Dato' Low Keng Huat, etc. MBAM hoped Hua Zong would support MBAM to raise up issues to the government and welcomed the opportunity to work closely with The Federation of Chinese Associations Malaysia and to explore mutually beneficial cooperation.

Next the President of the Hua Zong, Tan Sri Pheng opened the floor for discussion which touched on issues such as Government to Government awards of construction jobs to China companies, E-Card Enforcement, 44th International Federation of Asean and Western Pacific Contractors' Associations (IFAWPCA) Conference to be hosted by MBAM in 2018 and 63rd MBAM Anniversary Dinner 2017. Hua Zong highlighted the issue that most of the China contractors brought their own workers and also imported building materials directly from China to be used in their projects here, as such there were minimal benefits for the Malaysian economy and the Malaysian contractors. It was agreed by all that future Government to Government projects contract should clearly state to include local contractors and building materials suppliers participation. MBAM and Hua Zhong hoped the Malaysian government would look into this proposal.

The dialogue session concluded with an exchange of mementos between MBAM President, Mr Foo Chek Lee and Hua Zhong President, Tan Sri Pheng Yin Hua to commemorate the fruitful visit and dialogue. MBAM hoped both organisation would continue to provide each other support in facing challenges ahead.

INTERVIEW WITH SIN CHEW DAILY

MBAM President, Mr Foo Chek Lee was interviewed by Sin Chew Daily on 20th June 2017 at the President's room. The topic discuss were related to the recent fire at the Grenfell Tower block of public housing flats in London. The reporter asked whether the high rise buildings in Malaysia are built with safety in mind. Mr Foo stated that the building by laws required the submitting person to detail out and comply with the BOMBA's requirements for all high rise building. In addition, The Uniform Building By-Laws 1984 requires all high rise structures to include a fire compartmentation floor with horizontal and vertical fire barriers on the building's outer surface to prevent fires from spreading vertically. With all this requirement in place, the buildings in Malaysia are relatively safe and complied to the safety requirements.
