MBAM TRAINING ON CPR AND FIRST AID AT WORKPLACE

MBAM Safety and Health Committee organised a customized Training on CPR and First Aid on 5th to 6th May 2017 at MBAM Training Centre. The training was conducted by Mr Sam Ghee Wee Sim who has served with the St John Ambulance Malaysia (SJAM) for 20 years since 1996. He had been teaching First Aid for 13 years as a qualified trainer in Basic First Aid, Advance First Aid, First Aid Trainer and Emergency Medical Air Rescue Service.

The CPR training was practical oriented in compliance with DOSH Guideline on First Aid in workplace. The training was well received with 20 participants attending the two-day class. This comprehensive two-day course emphasized teaching first aid and cardiopulmonary resuscitation (CPR) skills to our participants in line with their construction work requirements by providing them with knowledge to respond to
