CONSTRUCTION INDUSTRY EXHIBITION 2018 "BRINGING CONSTRUCTION INDUSTRY UNDER ONE ROOF"

On the same day of 13th November, YB Tuan Baru Bian also officiated the 3-day Construction Industry Exhibition 2018 with the theme "Bringing Construction Industry under One Roof" at the ribbon cutting ceremony at Exhibition Hall 1 & 2. The successful Malaysia International Construction & Infrastructure Technology Exhibition (MBAM OneBuild) was held in collaboration with MBAM during the 44th IFAWPCA Convention.

MBAM OneBuild is the only exhibition in Malaysia that exclusively focus on the construction and infrastructure industry. Being marketed as a construction professional trade event, the MBAM OneBuild 2018 Exhibition was endorsed by Malaysia External Trade Development Corporation (MATRADE) for its international trade fair status, and was fully supported by related Malaysian government bodies such as Construction Industry Development Board Malaysia (CIDB) and Malaysian Investment Development Authority (MIDA).

The Exhibition which took place from 13th until 15th November had a total of 251 booths and attracted over 4,600 visitors with 14.4% foreign visitors. In addition, there was a free-admission Concrete Seminar presented by Academy of Concrete Technology and a Concrete Clinic set up by American Concrete Institute Malaysia Chapter to provide free consultancy on concrete issues. Other events held concurrently with the exhibition included networking sessions, live demonstration, construction CSR programmes and IPAF Malaysia Forum 2018.

BUILDING & CONSTRUCTION CONFERENCE "GLOBAL MEGA WAVE"

On 14th November, the Building & Construction Conference took place at the Grand Ballroom of Kuala Lumpur Convention Centre, which saw the participation of over 800 attendees.

The keynote address was provided by Professor Dr. Woo Wing Thye who touched on the Belt & Road Initiative (BRI) that China is undertaking. He mentioned that the members of IFAWPCA could all benefit from this BRI even though there is a lot of doubt and concern about the true nature of this initiative. The eminent professor sought to allay

these fears by providing a picture of what China really hopes to achieve.

The Conference then proceeded with the presentation by Professor Dr. Anil K. Gupta who is the Chairman of the China India Institute, United States of America. He touched on the rise of emerging markets, infrastructure boom, focus on green initiatives, digitisation, transformation of mobility, communal millennials, and ageing populations which he said is a crisis which is brewing as care for the elderly without enough infrastructure for the aged is becoming a problem.

In the panel discussion on External Threats & Opportunities moderated by Professor Mahendhiran S. Nair, the CEO of Monash Malaysia R&D Sdn Bhd, the panellists comprised of various different experts sat together to share their knowledge and viewpoints. Professor Tan Sri Dato' Dr. Lin See-Yan talked about global economics, Mr Chris de Lavigne shared about the growth of infrastructure and construction sectors in Asia and YB Nurul Izzah Anwar highlighted the need to reform the Technical Vocational Education and Training (TVET) programme in Malaysia.

The Conference continued after lunch with keynote address by Project Director of MRT Corp, Dato' Amiruddin Ma'aris who shared about the challenges faced with the construction of a major infrastructural project which is the Sungai Buloh-Serdang-Putrajaya Line as part of his presentation.

The session then proceeded with another panel discussion on Industry Challenges moderated by Dato' Sri Idris Jala who is the President and CEO of Pemandu Associates. The panellists consisted of Dr. John Keung who talked about Singapore's experience in building and construction, Ir. Parameswaran

Sivalingam, a well known project director from MMC Gamuda KVMRT and Mr Michael J. McIver, an expert in the contractual and commercial aspects of building and civil engineering projects.


weaving, batik painting, songket weaving, wood carving, henna painting and Chinese calligraphy with the sound of Gamelan serenading in the background while guests mingled around.

C & P PROGRAMME 7: CONSTRUCTION CONTRACT LAW PRINCIPLES PROCUREMENT SYSTEMS AND CONTRACTUAL ARRANGEMENTS

MBAM Executive Director, Ms Loh Mei Ling delivered the welcome speech during the 7th session of the Practical Construction Contract Administration/Management based on 48 BK ENTRUSTY's articles published in MBAM Journal from 2002 to 2016, which attracted 40 participants on 29th November at MBAM Training Centre.

The focus was on Construction Contract Law Principles and Procurement Systems and Contractual Arrangements.

Construction law is a branch of law that deals with matters relating to building construction, engineering and related fields. It is in essence an amalgam of contract law, commercial law, planning law, employment law and tort. Construction law covers a wide range of legal issues including contract, negligence, bonds and bonding, guarantees and sureties, liens and other security interests, tendering,

construction claims, and related consultancy contracts. Construction law affects many participants in the construction industry, surveyors, architects, builders, engineers, construction workers and planners. The following principles were dealt with in the session:

- The Malaysian Legal System
- Essential Legal Aspects of Contracts
- ◆ Remedies for Breach of Contracts and Torts
- Particular Aspects of Building and Construction Contracts and
- ◆ Salient Provisions in Building and Construction Contracts

Procurement systems and contractual arrangements were also other interesting topics covered in this programme.

OFFICIAL LAUNCH OF AIAC STANDARD FORM OF CONTRACT

Official Launch of AIAC Standard Form of Contract was held on 28th November at the Asian International Arbitration Centre (AIAC) Auditorium in Bangunan Sultan Sulaiman, Kuala Lumpur and was attended by MBAM Vice President and Chairman of Contracts and Practices Committee, Mr Oliver Wee and MBAM Assistant General Manager, Mr Lenny Lim. The Acting Director of the Asian International Arbitration Centre (Malaysia), Mr Vinayak Pradhan delivered the welcome speech.

In furtherance to the launch of a suite on Standard Form of Contracts (the "SFC") on 15th August 2017, the AIAC introduced its Standard Form of Design and Build Contracts at the above event.

The AIAC 2019 SFC is a comprehensive unified contract that does away with the distinction between With and Without Quantities. Users can now customise the contract to meet their specific needs. Furthermore, the AIAC 2019 SFC provides an option for the Parties to select a Contract Administrator (CA). If no CA is appointed, then the Architect will be the CA. The dispute resolution sections of the AIAC 2019 SFC incorporates the AIAC Arbitration Rules 2018 and the 2005 Arbitration Act (as amended 2018) and provides for adaptability to the latest tax regime. Since the inception of the Standard Form Contracts, there have been 19,000 visitors to the AIAC SFC web portal. Also, a total of 46,000 AIAC SFC forms have been downloaded with 250 contracts customised. Furthermore, there has been 3,500 roadshow delegates with over 15,000 copies disseminated and 6 in-house company trainings.

The AIAC is the first arbitral institution in the world to launch a suite of this kind that is suitable for all building construction projects in both Malaysia and abroad as it can be easily adjusted to the needs of a particular user.

APPEAL ON SST AND TREATMENT OF GST ON RETENTION SUM

Real Estate & Housing Developers' Association Malaysia (REHDA) and MBAM have managed to secure a meeting with the Royal Malaysian Custom Department to discuss on the above issue facing our members in the construction industry. The meeting was held on 30th November 2018 at the Director General of Customs' Office in Putrajaya. MBAM President, Mr Foo Chek Lee; MBAM Vice President, Mr Dennis Tan; MBAM Treasurer General, Mr Kenneth Liew; MBAM Honorary Advisor (Taxation), Mr Yee Wing Peng and MBAM Executive Director, Ms Loh Mei Ling attended the meeting.



The Customs Department do not allow any issuance of tax invoice after the 31st August 2018. As for the Retention Sum payment, they will consider for closure by June 2020. If there are still outstanding payment after this date, special approval need to be sought from the Customs Department. They are also reviewing the SST for inter-company transfer of staff.

We will update members upon receipt of the new directive from the Customs Department.
