The Government recently tabled the Budget 2018 on 27th October 2017. Master Builders Association Malaysia (MBAM) would like to

congratulate the Government for a budget that continue the delicate balancing act between maintaining fiscal prudence, managing growth as well as the people's well-being. A total of RM280.25 billion is allocated for Budget 2018, an increase of RM19.45 billion or 7.45% increase compared to Budget 2017 allocation of RM260.8 billion. According to the 2017/2018 Economic Report, the construction industry is forecasted to grow at 7.5% supported by ongoing infrastructure projects.

The Association also welcomes the priority afforded to people-centric projects such as affordable housing, rural housing, hospitals, roads and infrastructure upgrades such as airports.

Still on the issue of foreign workers' remuneration, he highlighted that MBAM had scheduled a talk on "Foreign Workers' Liability to Pay Income Tax" on 31st October 2017 at MBAM Training Centre. In conjunction with the Talk, there would also be a briefing on the latest requirements for recruitments of foreign workers including the workers accommodation requirements for the construction industry.

On another note, he informed that the Employment Insurance Scheme (EIS) was passed by the Parliament and would take effect in January 2018. In addition he touched on the salient points of the just announced Budget 2018 and in particular those related to the construction sector. He spoke of the government's push for more affordable housings, and on the overall country's economy is set to expand by 5% to 5.5%. Mr Foo concluded his speech by wishing SKLPA all the best and for continuity of growth and progress in years to come.

TALKS ON LATEST HUMAN RESOURCES ISSUES IN THE CONSTRUCTION INDUSTRY

The Human Resources Committee has invited representatives from the Inland Revenue Board to enlighten MBAM members on the foreign workers' liability to pay income tax on 31st October 2017 at MBAM Training Centre. Presently, majority of MBAM members are not aware of the Income Tax Act (section 7) ruling where a foreign workers become liable to pay income tax when he is deemed a resident after having been in Malaysia for 182 days or more. All foreign workers engaged in the construction industry consists of general workers where levy is paid on a yearly basis to the Department of Immigration Malaysia.

The talk was well attended by 71 participants. Present at the talk was MBAM Vice President and Chairman of Human Resources Committee, Ir. Chuan Yeong Ming, HR Committee Members, Mr Mazlan Haron and Ms Joanne Ng. Ir. Chuan Yeong Ming presented a short welcome remarks highlighting the importance of the said issue.

Invited speakers namely Mr Megat Mohd Irwan Ibrahim and Mr Loganathan Muniandy, Executive Officers from the Non Resident Branch, Inland Revenue Board of Malaysia briefed members on their responsibility for their foreign workers under the Income Tax Act 1967.

Employers are currently **already required to submit Form CP22 (Pin.1/2011) to notify the IRB of new employees** under Subsection 83(2) of the ITA. This requirement could also be applicable to foreign workers.


Employers are required to carry out the monthly tax deduction based on the local workers schedule with effect from the August 2017 salary onwards. In the case of fluctuating income, tax deduction is to be made for any month on which a foreign worker has employment income of RM2,851 (minimum monthly remuneration subjected to MTD for single individual) and above based on the 2017 MTD Schedule.

As there are many enquiries related to the construction sector, the invited Officers informed that there is a team in the IRB who handle cases for construction firms. MBAM will invite the said team to further deliberate issues related to the construction sector.
