1<sup>st</sup> Payment – Agent Fee, Penalty, FOMEMA, Processing Fee (CLAB)

2<sup>nd</sup> Payment – PLKS & Levy, Agent Fee, CIDB Green Card, Processing Fee (CLAB)

We are pleased to inform that Master Builders Association Malaysia and Construction Labour Exchange Centre Bhd (CLAB) are collaborating to assist MBAM members in particular small construction companies who are unable to register their illegal foreign workers (PATI) through the REHIRING PROGRAMME.

As of 30<sup>th</sup> March 2016, the Government has given approval to CLAB to act as the Employer for the construction industry foreign workers under the Rehiring Programme. Under this arrangement, the Company Directors are not required to register their thumb print with the Immigration Department, Malaysia.

All application must be submitted to MBAM for vetting before submission to CLAB. Kindly bring along your original documents for verification purpose. We are pleased to forward the following for your attention.

- a. CLAB Check List for Rehiring Programme
- b. CLAB Rehiring Programme Application Form
- c. CLAB Sample of Payment Advice for Rehiring Programme (Indonesian Workers)

Members who are interested to register their illegal workers are requested to complete the attached application form together with necessary documentations as listed in the Check List for Rehiring and bring over to MBAM Secretariat for verification purpose soonest possible.

## **IMPORTANT REMINDER !!**

We would like to remind members that the deadline for registration of E-Card is **30<sup>TH</sup> JUNE 2017**. As per the latest announcement by the Government, all PATI are required to apply for rehiring prior to registration for E-Card. As such, we urge members to take this opportunity to immediately register your illegal PATI under rehiring programme. Please take note once enforcement is implemented after this deadline, stern penalty will be taken against Employers caught with harbouring illegal foreign workers.

## **ADMINISTRATIVE CHARGES BY MBAM**

Please note a non-refundable administration fee of **RM53.00 (including GST)** per person for MBAM member and **RM106.00** per person for non-MBAM member will be collected for each PATI.

## **WHO SHOULD REGISTER**

- a. Construction Companies with CIDB registration who need to legalise their illegal workers (with valid passport copy).
- b. Construction Companies without CIDB registration (to assist for CIDB registration) and need to legalise their illegal workers.
