LHAG's Practical Tips & Updates: Enforceability of LAD Clauses in Construction Contracts

Liquidated damages clauses in construction (and other commercial) contracts are intended to encourage quick (and pre-agreed) resolution of disputes arising out of delays and other breaches of contract. However, Malaysian law dating back to the 1880s appears to undermine these commercially driven agreements and, instead, promotes litigation. By contrast, in a recent landmark decision (*Cavendish Square v Talal El Makdessi*), the English courts have moved to align the law on liquidated damages with modern commercial reality. What lessons can we learn from the new English jurisprudence?
