We are pleased to inform that MBAM has met up with Tuan Lim Guan Eng, Minister of Finance on Monday, 4<sup>th</sup> March 2019 to discuss the critical issues facing the construction industry.

One of the critical issues discussed was on the delayed and unpaid works for Government projects. In order for the Ministry of Finance to assist to resolve this issue, the Minister has requested detailed information on outstanding payments not received on Government projects which have been undertaken by MBAM Members. As such, any members facing this issue are requested to provide details of the non-payment projects, amount involved in RM and the due date of payment and any other information which will provide better clarity to the respective claims.

Kindly submit the said information **on/before Friday, 8<sup>th</sup> March 2019** for MBAM Secretariat to compile and forward to the YB Minister.
