Dear Members,

Further to our earlier circular reference MBAM/25/19/2018/12/20/40 dated 19<sup>th</sup> December 2018 on the appeal on SST and Treatment of GST on Retention Sum, we would like to update members on the latest on the **Amendments to the Royal Malaysian Customs Department (RMCD) Director General's Decision 1/2018 & 3/2018**, a copy of which is attached for your attention. The information is also available in the RMCD's website at [mysst.customs.gov.my](http://mysst.customs.gov.my)

We wish to advise members to submit your application to the DG of RMCD before **29<sup>th</sup> December 2018** if you wish to apply for extension of time to account for tax or claim input tax after the expiry of 120 days, i.e. **29<sup>th</sup> December 2018**. However, please note that the approval for extension of time may only be given depending on the merits and grounds which are acceptable and reasonable such as retention sum where defect liability is given for a period beyond 29<sup>th</sup> December 2018. As such, you may be required to explain clearly in your application why you wish to apply for the extension of time for the deferment of the GST payment.
