CIDB CERTIFIED CONSTRUCTION MANAGER (CCM) PROGRAMME

We wish to highlight that CIDB Malaysia is currently taking steps to certify and accredit Construction Managers in compliance with the Construction Industry Competency Standard (CICS) via the Certified Construction Manager (CCM) Programme. Under the Clause 33(1) of the CIDB Act 520 (Amended 2011), it is stated that a person who contravenes subsection (1) shall be guilty of an offence and shall, on conviction, be liable to a fine not exceeding five thousand ringgit.

There are 3 methods for accreditation namely;

- 1. Training & Assessment
- 2. Assessment only
- 3. Interview or Recognised Prior Learning and Experience (RPLE)

Thus for a start, members are advised to send potential candidates for accreditation via METHOD 3 - INTERVIEW SESSION. The registration fee is RM100.00 per person and RM200.00 for certification upon passing the interview. The first interview session is proposed to be held on 27th & 28th November 2019 at CIDB PWTC.
