ADHERENCE TO THE MOVEMENT CONTROL ORDER BY THE MALAYSIAN GOVERNMENT

Following the announcement made by the Honourable Prime Minister yesterday on 16th March 2020 at 10.00pm, it has been declared that the entire country will be on a Movement Control Order starting from 18th March until 31st March 2020 as precautionary measures by the Malaysian Government to mitigate the spread of the COVID-19 virus and safeguard the health of our communities.

- To ensure all construction works are free from any damage or possibility from being stolen;
- To ensure documents and project records are safe at work site; iii.
- To record photos of project progress at work site on the current day; iv.
- To take all necessary steps to ensure that all of your obligations to the work are continued after the prohibition directives
