Application for Foreign Construction Workers (Bangladesh) – Special Approval Quota

We received the official letter from the **Construction Labour Exchange Centre Berhad (CLAB)** today in regards to the above-mentioned issue. **CLAB** has been mandated by the Government to administer the special approval quota for **foreign construction workers** from **Bangladesh**. This initiative is introduced to address labour shortages in the construction sector and to provide contractors with a faster, transparent, and structured application process. This exclusive special approval quota for Bangladeshi construction workers is open to all contractors across grades **G1 to G7**.

Members are advised to take note of the following key details:

- **Applications are restricted to Bangladeshi nationals only.**
- **Applications must be submitted directly to CLAB.**
- **Quotas are limited and processed strictly on a first-come, first-served basis.**
- **Closing date: 30 November 2026.**

Application requirements for special approval:

- i) **Employers must not be blacklisted by CIDB.**
- ii) **Must have an active project for a minimum of 6 months.**
- iii) **Salary payments must be made through CLAB's eSalary system.**
- iv) **Must demonstrate strong financial standing.**
