requires Project Managers to appoint experience, knowledgeable and having relevant and sufficient skills as Lifting Supervisors, Signalman and Rigger for operations, controlling and maintenance of cranes.

Any violations to the new order, a fine of not more than RM 200,000.00 or jailed not more than 5 years or both.
