POSTPONEMENT OF THE 66TH MBAM ANNUAL GENERAL MEETING IN COMPLIANCE TO THE DIRECTIVE FROM THE DEPARTMENT OF REGISTRAR OF SOCIETIES (JPPM) DATED 16 MARCH 2020

 - d. The Treasurer-General's Report and the Audited Accounts for the Year Ended 31 December 2019;
 - e. Nomination for Election of the Council:- List of MBAM members, Consent Form and Nomination Form; and
 - f. Reply slip and Proxy form.
4. In the meantime, the current Council 2018 - 2020 shall remain in office until the new Council 2020 - 2022 is elected at the re-scheduled AGM in accordance with the provisions of the Constitution.
