The Covid-19 PCR and/or RTK Antigen tests (which are recognised by the Ministry of Health, Malaysia), will be conducted by the approved vendors, and for our Members' convenience, via on-site screening. For the moment, the available areas for on-site screening covers the Klang Valley (Selangor & Kuala Lumpur), Negeri Sembilan, Penang and Johor Baharu.
