A. HONORARY LIFE MEMBERSHIP AWARDS

CRITERIA AND PROCEDURES FOR NOMINATION OF HONORARY LIFE MEMBERSHIP

Nominations will be called for annually via the newsletter, the website of MBAM and circular. Nominations by Members must be received by **2 June 2023**.

Qualification for Honorary Life Membership

Ensure that the candidate fits the criteria for Honorary Membership, that is:

1. Honorary Life President Award

- Served as Past President of MBAM for one full term.
- The number of Honorary Life President shall be not more than three (3) at all time but no compulsion for immediate replacement.
- Active participation and contribution to the Association after his term as President.

2. Honorary Builder Award

Provide a profile of the candidate (any natural person, company, firm or corporation) that provides grounds for the nomination. Pertinent information would include but not necessarily be limited to the following:

- The candidate's contribution to the field of contracting, building or construction wherever situated;
- The candidate's contribution to MBAM;
- The candidate's length of membership of the Association (if applicable);
- The candidate's overall contribution to the nation.
- The candidate's overall contribution to the regional level.

Selection and Conferment Procedures

The Awards & Constitution Committee will examine the nominations received and taking into account the criteria for Honorary Life Membership, make a recommendation at a Council Meeting for one, and under special circumstances more than one, Honorary Life Membership. The approval and acceptance of the candidate as Honorary Life President or Honorary Builder (as the case may be) shall be by unanimous vote in a Council Meeting.

In addition to the stated criteria, the sub-committee should provide an ongoing review of the gender, regional and disciplinary distribution of Honorary Life Members. Where marked discrepancies in the distribution occur, the Committee should implement positive discrimination procedures.

Notification to the Approved Honorary Life Members

Upon approval of the Council of a candidate, the Secretary-General shall issue an invitation in writing to the said candidate to become an Honorary Life Member of the Association and that the Conferment shall occur at the Anniversary Dinner of the Association.

Advertising the Council's Decision

The decision of the Council will be recorded in the Council Meeting minutes. Following the Secretary-General's letter to the approved candidate, the Candidate shall reply in writing its acceptance or refusal of the conferment within the time stipulated in the invitation.

Upon, the candidate's official acceptance of the Honorary Life Membership, the conferment will be published in the bulletin/Master Builder Journal/website of MBAM.

Conferment of the Honorary Life Membership

The Anniversary Dinner Organising Committee will arrange for a time during the Dinner or any other suitable event as per decided by the MBAM Council for the Conferment of the Honorary Life Membership. Sufficient time should be allowed for:

- the President or the President's nominee to present a citation.
- the candidate to respond;
- the President to present the Honorary Life Membership Award /Plaque/Certificate.

The Honorary Life Membership Certificate

A certificate will be presented to the Honorary Life Member that registers the Honour bestowed by the Association. The candidate's name shall be recorded in the Association's Register of Members and be entitled to all the privileges of membership.
