The following were some of the questions asked at the panel session and the following was our draft reply:-

1. WHAT ARE THE CHALLENGES YOUR ORGANISATION WILL FACE IN MOVING FORWARD TO CR4 AND COMPLYING WITH ESG?


Many Industry players have done their roadmap on both (CR4.0 & ESG) and are progressing well in their journey. With the influx of young professionals, we believe the adoption shall be progressing well with the implementation for both (CR4.0 & ESG).

At the same time, we also observe that many contractors are not starting their journey yet despite MBAM's constant effort to keep pursuing and encouraging the industry players (especially our members) to kick start their journey in both CR4.0 and ESG if they want to stay relevant in the industry.

2. WHAT ARE THE SUPPORTS YOUR ORGANISATION WILL REQUIRE FROM THE AUTHORITIES FOR ESG AND CR4?

There must be pervasive awareness programmes so the industry players are well aware on CR4.0 and ESG requirements. Relevant authorities and government bodies are to provide awareness on the technical and financial support to kick start their journey in their business on CR4.0 and ESG.

The hold back are the cultural factor (previous procedures & way of doing things) and cost. But when they realise the importance of the transformation and the ROI, they will start the journey. The research shows that in 2020, the construction sector allocates 2% of their budget to invest on IT operations.



3. WHAT WOULD BE THE IMPACT OF CR 4.0 TO YOUR PROFESSION / ORGANISATION?

It will help improve the construction value chain and help push our members and the construction industry at large to be more productive and competitive. Nonetheless at the same time, those who refuse to walk the journey will be phased out soon.

Decision making is an important role for managers. Based on figure below, relate it to the downfall of Nokia



Nokia has been a respectable company. They didn't do anything wrong in their business, however, the world changed too fast. Their competitions were too powerful.

They missed out on learning, they missed out on changing, and thus they lost the opportunity at hand to make it big. Not only did they miss the opportunity to earn big money, they lost their chance of survival.

The message of this story is, if you don't change, you shall be removed from the competition.



At the time, Kodak was the dominant brand in the US photo industry, and Kodak didn't want to cannibalise its film businesses. Kodak eventually did make the big switch to digital a mere 18 years later.

Eastman Kodak filed for bankruptcy in 2012.

4. WHAT DO YOU THINK IS YOUR ROLE IN PROMOTING THE CR4?

MBAM encourages and continues to promote CR4 as what we have done through education and training via forums, seminars, webinars and articles in our publications to educate our members and industry players. Nevertheless, any additional help from the Government will help to expedite the journey on CR4. We are prepared to collaborate with any Government authorities and institution which are willing to come and help expedite the journey. We also engage Government representatives such as MDEC and BNM to get the assistance we need and share information on grants or loans that can help out members.

5. WHAT ARE THE CONTRAINTS AD HURDLES THAT WILL BE FACED IN YOUR PROFESSION OR YOUR CONTRIBUTION IN CR4? YOU MAY SHARE YOUR IDEAS...

We hope the Government will reach out to other stakeholders (Developer, Consultant, Manufacturer, Supplier & etc.) and take macro points of view especially in policy making to make sure CR4 will make an impactful meaning to the industry.

MBAM also hopes to be included in the earlier stages when the government or related bodies formulate or amend any policy related to the CR4. This is to avoid unfavourable policies that may not have support from industry players.

Overall, it was an interesting session which enabled the experienced panelists to engage the incoming young professionals coming into the construction industry.


MBAM Fellowship No.7/2022

The MBAM Fellowship 7/2022 event took place on 11th November 2022 at Opus Residence, Kuala Lumpur.



45th IFAWPCA Convention

MBAM President, Mr. Oliver HC Wee led a 21-MBAM member delegation to the 45th IFAWPCA Convention which was recently concluded on the 15th to 19th November 2022 hosted by the Maldives National Association of Construction Industry (MNACI) in Maldives. The convention was already delayed twice due to the Covid-19 pandemic and this is the first time in IFAWPCA history that Maldives is hosting an IFAWPCA Convention.

The 45th IFAWPCA Convention with the theme "Construction with Conservation – Build a Better World" was attended by approximately 300 delegates from 19 countries from the Asian and Western Pacific region. At the opening of the 45th IFAWPCA Convention, the Vice President of the Republic of Maldives Faisal Naseem highlighted that the construction industry adoption of green technology will help to fight against climate change. Maldives is witnessing a massive construction boom but is also vulnerable to rising sea levels because of its low terrain. Meanwhile, President of the Republic of Maldives, H.E Ibrahim Mohamed Solih also took the initiative and attended the Welcome Dinner to meet with IFAWCPA members.

Traditionally, the convention was well attended by prominent players in the construction industry where members were able to meet local contractors and businessmen as well as other IFAWPCA players in the building and construction industry to share, discuss and update on construction related matters. MBAM President, Mr. Oliver H.C. 55th Building Industry President Council Meeting (BIPC) Meeting



The above meeting on Wednesday, 30th November 2022 was attended by MBAM President, Mr Oliver HC Wee, MBAM Secretary-General, Datuk Astaman Abdul Aziz, MBAM Executive Director, Ms Loh Mei Ling at RISM HQ, Bangunan Juruukur, Petaling Jaya.

The following issues were discussed:

• Shortage of Labour issues

A joint press statement with the Persatuan Kontraktor Melayu Malaysia (PKMM), Persatuan Kontraktor Bumiputera Malaysia (PKBM) & Persatuan Kontraktor India Malaysia (PKIM) on "Difficulties to Bring in Foreign Construction Workers" was issued on 29 September 2022 and the coverage was shared with BIPC

Building Assessment Report for Defect during Defects Liability Period - Completed Housing Projects

Reference was made to building assessment reports which were prepared by 'so called defect inspectors' engaged by homeowners for completed housing projects. Many of these reports contained hundreds of alleged building defects which most of the alleged defects were within the contract tolerance and/or industry tolerance. Some of them even demanded for flawless workmanship and/or quality, and some of them were purely aesthetic in nature. This was also in line with PAM Practice Notes which were circulated to their members in October 2022.

We strongly believe that many main contractors are facing the same problem. If this scenario continues, there would be a very high tendency that main contractors will

price in this risk during the housing project tender stage in which will eventually lead the developer to pass on these costs to home buyers. This will promote a price increase in the property industry which impede the purchasing power of home buyers, especially for first-time buyers.

The following are some of the suggestions for the consideration of BIPC to take up:

- 1) Accreditation by Construction Industry Development Board to make aware the defect inspectors on the standard of acceptable tolerance.
- 2) Only accredited defect inspectors shall be engaged to check defect on behalf of home buyers.
- 3) Introduction of clear guidelines for the acceptable tolerance.
- 4) The QLASSIC benchmarking standard would never be a 100% score, as such the defect inspectors shall allow some minor defects in their assessment.
