Budget Dialogue 2023



As the budget 2023 will be tabled on Friday, 24th February 2023, the Ministry of Finance has called for a meeting on Tuesday, 17th January 2023 at the Ministry of Finance Head Office in Putrajaya. The previous 2023 Budget with a RM372.billion allocation under the previous administration was tabled in the Dewan Rakyat in October by Tengku Datuk Seri Zafrul Abdul Aziz, who was the then finance minister. The budget however was not approved following the dissolution of the 14th Parliament to make way for the 15th General Election (GEI5).

Attending the meeting for MBAM was President, Mr Oliver HC Wee. The meeting was chaired by the Prime Minister, YAB Datuk Seri Anwar Ibrahim with the objective to obtain views from various organisations including Non-Governmental Organisations. Digital advancement, small and medium enterprises and green economy will be the focus of the revised 2023 Budget, says Datuk Seri Anwar Ibrahim.

The Prime Minister said that these were among the initiatives that will be given a boost in the Budget, given its importance and potential. He said some parts of the budget that was tabled by the previous administration would remain while there were some which require changes to be made.

Town Hall Session with LHDN

MBAM President, Mr Oliver HC Wee, MBAM Honorary Advisor (Taxation), Mr Yee Wing Peng and MBAM General Manager, Mr Lenny Lim attended a Town Hall Session with LHDN CEO, Datuk Dr. Mohd Nizom bin Zairi at Intercontinental Hotel Kuala Lumpur on Monday, 30th January 2023. In the Malaysian construction industry, disputes between and among contracting parties have become a norm in recent years. There are more than 1,000 cases at various courts related to construction contract disputes. In addition, adjudication and arbitration contributed to a substantial disputed amount which is in billions of Ringgits. Many of this are work done and payment certified but not paid. However, contractors would have paid the tax in accordance to the certified amount. With the current situation, where many more compliances are imposed on doing business as well as the industry experiencing upward fluctuation of material prices, contractors have no cushion in cash flow to pay the taxes in advance. Therefore, we hope LHDN can consider all these disputed amount to be exempted from tax temporarily until the judgement is delivered.
